Oadby and Wigston Borough Council is publishing its Town Centres Area Action Plan Development Plan Document and associated Sustainability Appraisal for Public Consultation from Friday 28 October 2011 until **4.15pm on Friday 9 December 2011**.

The Publication Draft Town Centres Area Action Plan Development Plan Document is a planning document setting out the vision, and land allocation for the centres of Wigston and Oadby, alongside policies to facilitate sustainable delivery. The Sustainability Appraisal is a statutory document that assesses the methodology, objectives and conclusions of the Publication Draft Town Centres Area Action Plan and how sustainable the document is.

Objections and representations should specify the matters to which they relate and the grounds on which they are made. They may also be accompanied by a request for notification, at a specified address, of the submission, withdrawal, adoption, approval, rejection or publication of recommendations in relation to the proposals. Only objectors whose objections are made in writing and arrive at the address specified above within the six week period ending at **4.15pm on Friday 9 December 2011** will have a right to have their objections considered at the examination.

Copies of the Publication Draft Town Centres Area Action Plan Development Plan Document; Sustainability Appraisal Report; Statement of Community Involvement; Statement of Representation Procedure; Statement of Consultation; Statement of Fact and, Supporting Documents will be available at Oadby & Wigston Borough Council Offices, Station Road, Wigston, LE18 2DR free of charge between the hours of 8.45am and 4.45pm on Mondays to Thursdays and 8.45am and 4.15pm on Fridays. They will also be available at Oadby Library, Wigston Library, South Wigston Library during their normal opening hours and online at www.oadby-wigston.gov.uk.
