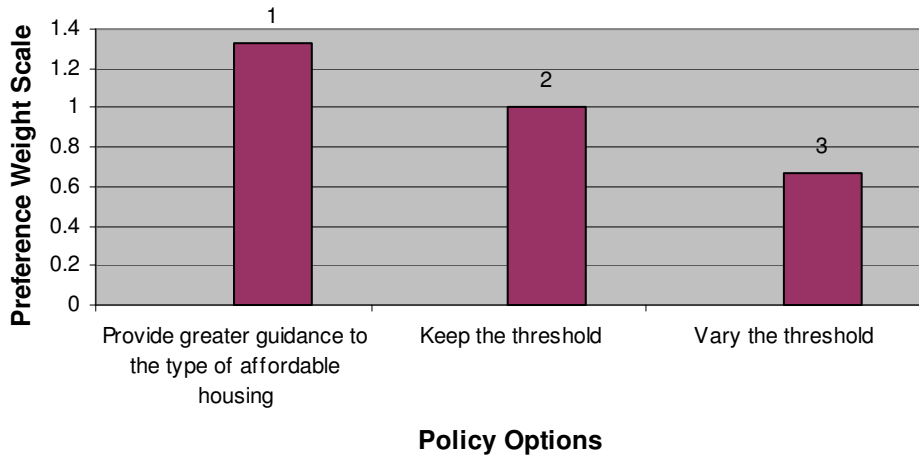




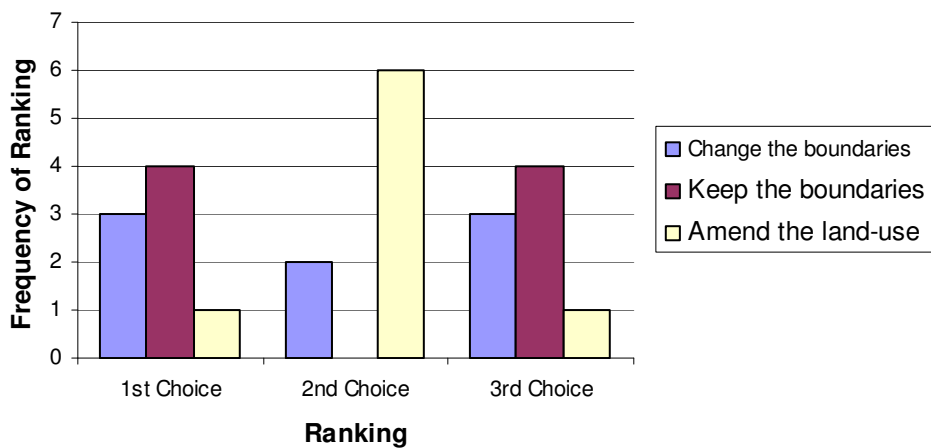
Do you agree that employment areas should be safeguarded specifically for employment uses?



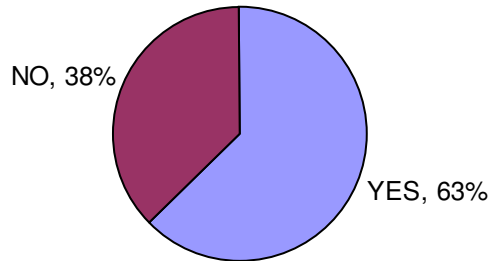
Preferences for Affordable Housing Policy



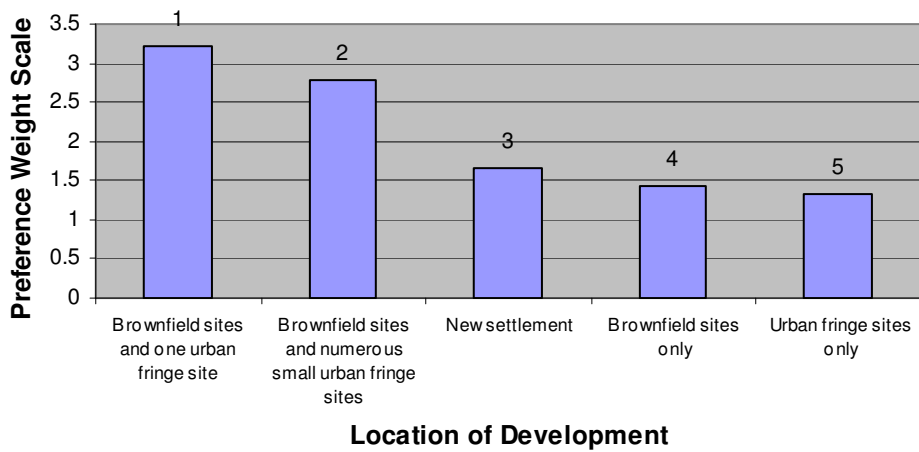
Green Wedge Management and Use



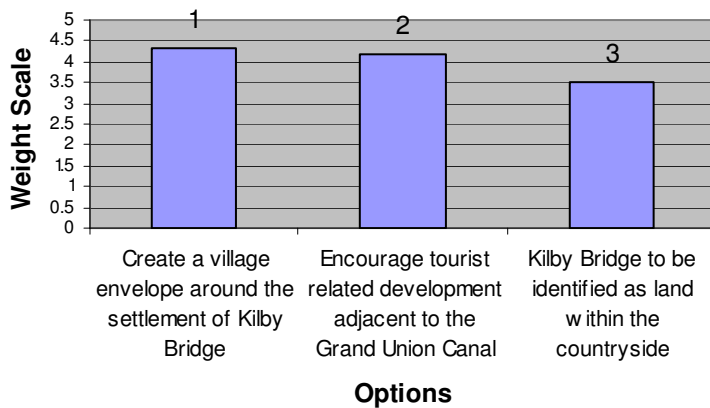
Do you feel that the 10 key issues identified are the correct ones?



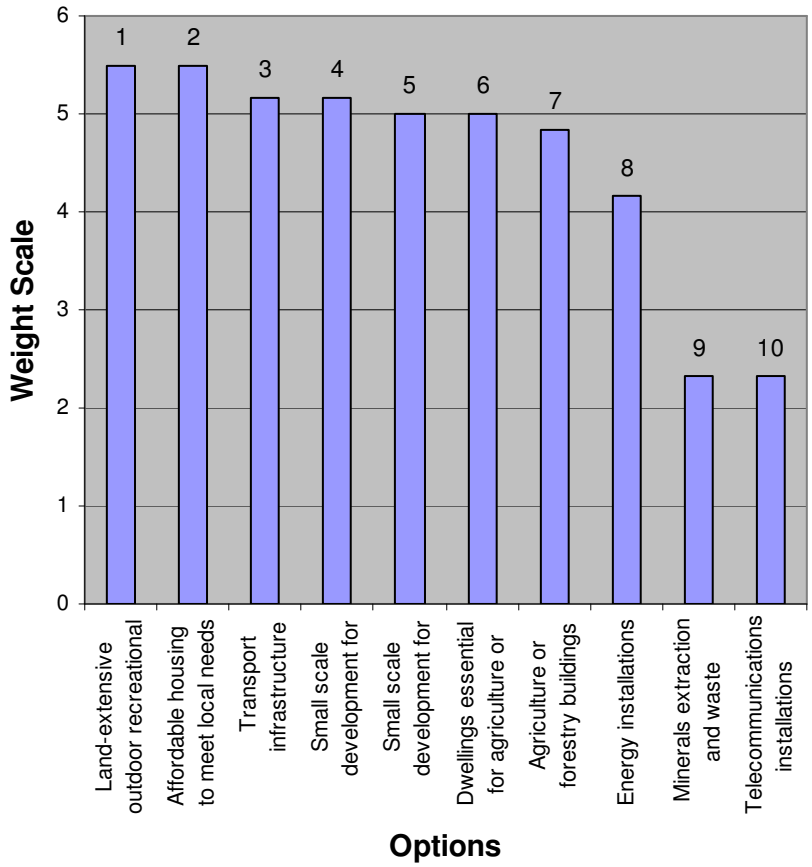
Location of Development Preferences
