### **Title of Document:**

Oadby and Wigston Local Development Framework – Core Strategy Development Plan Document (Publication Draft Proposed Submission Document) October 2009

### **Subject matter and area covered:**

Oadby and Wigston Borough Council has published its Core Strategy Development Plan Document for formal representations prior to its submission to the Government for independent examination. The Core Strategy is the principle planning document of the Oadby and Wigston Local Development Framework, which is a collection of documents that, along with the East Midlands Regional Plan, form part of the Development Plan covering the Borough.

The Core Strategy sets out the key planning framework for future development in the Borough of Oadby and Wigston up to 2026. It contains the Borough Council's spatial vision and strategic objectives, a spatial strategy, core policies and a monitoring and implementation framework to measure delivery of the vision and objectives.

### **Period within which representations must be made:**

The statutory period for making representations in relation to the 'legal compliance' and 'soundness' of the Core Strategy Development Plan Document is for a period of 6 weeks starting on Monday 19 October 2009. **Representations must be submitted no later than 5:00pm on Monday 30 November 2009.**
