

Supplementary Planning Document(s) and Statement of Community Involvement – Adoption Statement 24th April 2019

This Adoption Statement has been prepared in accordance with Regulation 14 and Regulation 35 of the Town and Country Planning (Local Planning) (England) (Amendment) Regulations 2017.

Notice is hereby given that Oadby and Wigston Borough Council resolved to adopt the Conservation Areas Supplementary Planning Document; the Residential Development Supplementary Planning Document; the Developer Contributions Supplementary Planning Document; and, the Statement of Community Involvement, at its Full Council meeting on Tuesday 16th April 2019.

Each of the Supplementary Planning Documents and the Statement of Community Involvement are updates on documents previously adopted by the Council. Each of the documents mentioned above were subject to a 6 week public consultation, between midday Monday 8th October 2018 and midday Monday 19th November 2018.

Further information relating to the consultations that took place and the representations received can be found in the relevant public consultation statement; Conservation Areas Supplementary Planning Document Public Consultation Statement 2018; Residential Development Supplementary Planning Document Public Consultation Statement 2018; Developer Contributions Supplementary Planning Document Public Consultation Statement 2018; and Statement of Community Involvement Public Consultation Statement 2018.

Any person aggrieved by the adoption of any of the above mentioned supplementary planning documents may apply to the High Court for permission to apply for judicial review of the Council's decision to adopt. Any application must be made within 3 months from the date on which the document was adopted (Tuesday 16th April 2019).
